TESTING OF AGUALUNG TANKS

At the last meeting of the Group considerate concern was expressed by several members at the varying prices charged by Dive Shops for testing tanks and also the apparant short term required by these shops between tests. In view of this expressed concern and in fairness to all the Committee had enquiries made and set out in the following paragraphs is the apparant situation.

Before going into detail it is desired to draw the attention of members to the need for special care at all times in handling their tamks, as when they are full to working pressure of some 2,300 P.S.I. there can, with mishandling, be danger of explosion and at this pressure a tank exploding releases considerable energy, for example - sufficient to lift a motor car 50 ft into the air or to hurl shattered particles of its own metal hundreds of feet with consequent loss of life or injuty to person and property. Some of the reasons why tanks may explode, spart from carelessness, such as dropping them on hard surfaces or tossing them about, are 01) weakening of the cylinder wall or ends due to internal corrosion, abrasive wear

(2) reaction between the oxygen of compressed air and oil or other hydrocarbon vapours resulting in a rapid and large increase in pressure

(3) application of pressure in excess of pressure for which the cylinder was designed

(4) excessive heating of charged cylinders, leading to increase in pressure.

A diver may well ask in view of this how he can be aware of these factors so that the risks are reduced to an absolute minimum. The obvious asnwer is by testing and to this answer there is always the reply that testing is a recket organized by the Dive Shops - Rubbish to such a statement - for our enquiries among the Dive Shops were received with friendly co-operation and the advice tendered was that regular inspection was the only safeguard to life and property as this is the only way to stop trouble before it starts - to the advantage primarily of the diver himself. It was ascertained that all Melbourne Dive Shops are guided by the Recommendations of the Standards Association of Australia - specifically in accordance with Safety Code A.S.C.B. 4 and supplement No 3 (1963) of that Code (Safety of Portable Compressed Air Cylinders used in Self-Contained Underwater Br athing Avparatus)

For the benfit of t ose who are not aware of the Standards Association of Australia (S.A.A.) and its work, it is advised that it was set up in 1922 as the Australian Commonwealth Engineering Standards Association and its function is to prepare and publish Asutralian Standards and to promote their adoption. Standards are in the form of specifications for materials and products, codes of sound and safe practice methods of testing etc. The Associations work is financed from Government Grants, members subseri subscriptions and sale of its publications.

The recommendations of the S.A.A. in regard to Aqualung tanks, as extracted from the above Code are set out for the benfit of members and it is considered that this will indicate that in following this code the Dive Shops are in fact the Divers Best Friend. 1. Frequency of Inspection - Cylinders (tanks) should be submitted for inspection by a recognized testing authority at intervals not exceeding 12 months or as otherwise laid down by State Regulations.

2. Inspection. Inspection of cylinders should provide for :-

(a) External examination - If there are signs of serious damagen such as denting, abr.sion, grooves or corrosion it should be condemned and destroyed.

(b) The cylinder should be examined internally with an electric lamp or intrascope. If it shows any serious defects, such as s plit necks, sever folds, or severe corrosion, it should be condemned and destroyed.

(c) Inspection of internal lining, if any, for signs of lifting or breaking. If there is any corrosion under the lining it should be removed to allow for proper examination and removal of r ust.

(d) Loss of weight. The cylinder less value or other connections, after cleaning, should be weighed. If the weight is less than 95% of the original bare weight, the <u>syntimerx</u> cylinder should be condemned. If possible thicknessof walls should also be checked if nowhere less than 95% of original thickness the tank may continue in use.

3. Hydrostatic Test.

Each cylinder which passed the above requirements should be <u>hydrostatically tested at intervals not</u> exceeding 12 months.

NOTE (1) Hydrostatic test alone is not a complete safeguard, as it primarily checks the presence of leaks or any undue expansion of the cyliner.

The Compressed Gass Association, Incorporated, of New York U.S.A. in advising on the care and maintenance of Diving Tanks also recommends hydrostatic testing at 12 monthly intervals.

NOTE (2) S.A.A. states that frequent overstressing may weaken a cylinder and therefore hydrostatic test should not be applied more frequently than as recommended above. This readers will note, is contrary to the statement made in a recent Skin Diver Magazine (U.S.A.)

It is felt that this should lay the allegations that the Dive Shops require inspections and testing too frequently for their own benfit.

Of course the matter of cost of such insepections and tests is another matter and the following details are as obtained from Dive Shops contacted in this regard - its a free country and you can choose your own Dive Shapr Shop for these services - no Dive Shop is going to unnecessarily condemn tanks or skimp on the tests they stand as much to lose as anyone by extremes in these fields.
